## Chapter 1

### Introduction & Background

This draft scheme was prepared under Section 11 of the Official Languages Act 2003 ("The Act") by the City of Cork Vocational Education Committee hereinafter referred to as "CCVEC". Section 11 of the Act provides for the preparation of a statutory scheme specifying the services which the public body proposes to provide:

- exclusively through the medium of the Irish Language
- exclusively through the medium of the English Language, and
- exclusively through the medium of both the Irish and English languages

and the measures the body proposes to adopt to ensure that any services that are not provided by the body through the medium of the Irish language will be so provided within an agreed timescale.

#### 1.1. Preparation of the Draft Scheme

This draft scheme has been drawn up by the CCVEC's Official Languages Advisory Group. The CCVEC published a notice under Section 13 on Friday, 21<sup>st</sup> July 2006 inviting representations from interested parties in relation to the preparation of the draft scheme

## 1.2. Ábhar na Scéime Teanga

Aithnítear réimsí do sholáthar seirbhísí trí Ghaeilge ó CGCC i gcroílár na scéime. Tá tiomantas cuimsithe sa scéim go ndéanfar measúnú ar bhonn leanúnach ar an leibhéal éilimh do sheirbhísí trí Ghaeilge, agus an riachtanas atá ann a chinntí go leanann CGCC leis an éileamh seo a shásamh ar bhealach pleánálte, soiléir agus inrochtana.

Titfidh an fhreagracht maidir le monatóireacht agus athbhreithniú na scéime ar an mbainistíocht shinsearach laistigh de CGCC.

## 1.3. Dáta tosaithe na Scéime

Tá an scéim seo faofa ag an Aire Gnóthaí Pobail, Tuaithe agus Gaeltachta agus tosóidh sé le héifeacht ón 30 Aibreáin, 2007. Fanfaidh sí i bhfeidhm ar feadh tréimhse trí bliana ón dáta sin nó go dtí go ndearbhaíonn an tAire scéim nua ag teacht le hAlt 15 na hAchta, cibé is luithe a thiteann amach.

## 1.2. The Content of the Language Scheme

The scheme recognises the goodwill which exists towards the Irish language in the CCVEC. This draft scheme is designed to build on this goodwill. Areas for the provision of services through Irish by the CCVEC are identified in the body of the scheme. The scheme also includes a commitment to assess on an ongoing basis the level of demand for services through Irish, and the need to ensure that the CCVEC continues to meet this demand in a planned, coherent and accessible manner.

Responsibility for monitoring and reviewing the scheme will rest with senior management within the CCVEC.

## 1.3. Commencement date of the Scheme

The scheme has been approved by the Minister for Community, Rural and Gaeltacht Affairs and will commence with effect from 30 April 2007. It shall remain in force for a period of three years from that date or until a new scheme has been confirmed by the Minister pursuant to Section 15 of the Act, whichever is the earlier.

## 1.4. Forléargas ar Choiste Gairmoideachais Chathair Chorcaí (CGCC)

### 1.4.1 Údarás agus Misean

Bunaithe faoin Acht Gairmoideachais 1930, 'sé CGCC an ceathrú ceann is mó den 33 Coiste Gairmoideachais sa tír. Cé gurb é Cathair Chorcaí an limistéar sainithe, soláthraíonn CGCC seirbhís acadúil ar scála réigiúnda chomh maith.

Is coiste reachtúil é CGCC a oibríonn faoi rialú chathaoirligh agus sé ghnáth-bhall déag. Cuimsíonn baill an CG ionadaithe ón réimse poiblí/tráchtála/tionsclaíochta, lucht foirne, ionadaithe na dtuismitheoirí agus comhaltaí oideachais. Tá líon fo-choistí mar thacaíocht ag CGCC.

Tá CGCC freagrach as 6 cinn de scoileanna agus coláistí. Is scoileanna dara leibhéal trí cinn acu seo, ceann díobh ina Gaelcholáiste, agus is coláistí Breisoideachais an trí cinn atá fágtha. Déanann siad 4 cinn d'lonaid Ógtheaghmhála a reachtáil chomh maith, lonad Oiliúna do Thaistealaithe Sinsearacha agus soláthraíonn siad seirbhís oideachais do Phríosún Chorcaí. Cuidíonn Coiste Gairmoideachais Chathair Chorcaí le haosaigh agus le daoine óga chun cláracha óige a fhorbairt trí chlubanna óige agus Tionscadail Óige pobal-bhunaithe, i gcomhar le heagraíochtaí aitheanta Óige Dheonacha agus grúpaí pobail áitiúla.

## 1.4. Overview of the City of Cork Vocational Education Committee (COCVEC)

### 1.4.1 Mandate and Mission

Established under the 1930 Vocational Education Act, CCVEC is the fourth largest of the 33 Vocational Education Committees in the country. Although its designated area is Cork City, CCVEC provides an educational service on a regional scale.

CCVEC is a statutory committee which operates under the governance of a chairman and sixteen ordinary members. Members of the VEC include public/commercial/industrial representatives, staff, parent representatives and educational interests. CCVEC is supported by a number of sub-committees.

CCVEC is responsible for 6 schools and colleges. Three of these are second level schools, one being a Gaelcholaiste, while the remaining three are colleges of Further Education. It also runs 4 Youthreach Centres, a Senior Traveller Training Centre and provides an education service in Cork Prison. The City of Cork VEC also assists adults and young people in the development of youth programmes through youth clubs and community based Youth Projects, in conjunction with recognised Voluntary Youth organisations and local community groups.

Adult and continuing education are also an important part of the CCVEC service.

A Community Education Programme operates throughout the City, in partnership with local groups and agencies, to provide basic education and leisure courses that complement the formal education sector.

CCVEC provides a wide range of opportunities for the younger generation of learners and its life-long education programmes offer adults in all age groups career improvement as well as leisure and self-development opportunities.

In the light of the mandate that has been given to CCVEC, the following mission statement has been adopted:

**“The City of Cork Vocational Education Committee will, as a leader and in partnership with others, provide learning and associated services which help people to achieve their potential as persons and to participate in society. The Committee will strive to promote social inclusion and to prepare people to participate in economic activity.”**

#### 1.4.5 Measúnú ar an bhfaersingeacht ina bhfuil seirbhísí trí Ghaeilge cheana féin ar fáil

‘Sí príomhchuspóir na hAchta ná fail níos fearr agus caighdeán arda de sheirbhísí poiblí trí Ghaeilge a chinntíú. Go dáta, seachas nuair atá déileáil á dhéanamh maidir le ceisteanna a bhaineann leis an nGaelcholáiste, níl seirbhísí an Choiste tar éis a bheith soláthraithe trí Ghaeilge, ach amháin nuair a lorg duine go sonrach déileáil leis an gCoiste trí Ghaeilge. I gcás Gaelcholáiste Daibhéid, sí an Ghaeilge an phríomhtheanga do stiúradh na gcruinnithe den mbord bainistíochta, agus soláthraítear na foirmeacha iarratais do phoist laistigh den choláiste i nGaeilge, chomh maith le doiciméadacht thacaithe.

In establishing the Gael Choláiste, the Committee responded positively to a requirement for a service to be provided in Irish. However, given the location and nature of its services and the composition of its client base there have been no other occasions where requests have been made to the Committee to provide services through Irish.

## Chapter 2

### Provision of General Committee Services/Activities

#### 2.1 Means of Communication with the Public/Information to the Public

CCVEC's policy is that an increasing number of publications and services such as the following are provided bilingually through the medium of Irish and English.

CCVEC's website is being re-developed and will provide a bi-lingual service as follows:

- Static items, such as Policy Statements, Annual Reports, etc. will be available in Irish by September 2007.
- Scholarship/Grants information will be available on a bi-lingual basis from the issue of the 2007/08 Scheme by the Department of Education & Science
- Information on vacancies will be available on a bi-lingual basis from September 2007

- The Committee will address the issue of making other detailed information and College/Centre websites available on a bi-lingual basis in the second and subsequent schemes.
- CCVEC will publish a dedicated e-mail address for queries ‘as Gaeilge’ on its Website

- **Interactive Systems:**

The Committee does not have any interactive systems currently in place. Any interactive service for the general public which will be put in place in the future will be introduced simultaneously in both languages.

- **Application Forms**

Application Forms for Posts in the Committee are available in Irish for posts in Coláiste Daibhéid and, for any other vacancy by September 2007. Supporting documentation for posts in Coláiste Daibhéid is currently available in Irish and will be made available, for all posts by September 2007

Student Grant/Scholarship Forms are available in Irish, as is the Scholarship/Grant Scheme details.

School Transport Application Forms are supplied in Irish & English on the one form by the Department of Education & Science.

## Chapter 3

### Summary of the Services/Activities provided by Schools and Colleges, other Centres and Internal Support Units.

#### 3.1 Introduction

This Chapter sets out the position in relation to the provision of services and activities in the various sectors of CCVEC. The first section of the Chapter refers to the schools and colleges, other centres, internal support units and to the official language regime operated in them. The second section describes their functions and activities.

#### 3.2 Schools, Colleges, other Centres and Internal Support Units working in Irish

Coláiste Daibhéid provides instruction through the medium of Irish to both Junior & Leaving Certificate Levels. Its Reception & Switchboard is bilingual and the Coláiste conducts its affairs (Board of Management Meetings, Minutes, Official Correspondence) through the medium of Irish, with the exception of technical documentation, which is considered in the language in which it is written.

#### 3.3 Schools, Colleges, other Centres and Internal Support Units working bilingually

### **3.3 Scoileanna, Coláistí, Ionaid eile agus Aonaid Tacaíochta Inmheánacha ag obair go dhátheangach**

All other CCVEC's schools, colleges, other centres and internal support units are not yet in a position to provide bilingual services. CCVEC however, will provide appropriate training for its staff to enable them to reach this goal and will promote the use of Irish as a medium of internal communication in CCVEC.

### **3.4 Schools, Colleges, other Centres and Internal Support Units working in the English language only**

The following is a list of COCVEC's schools, colleges, other centres and internal support units, which are not yet in a position to provide a one-to-one service in the Irish language. Their functions/activities are described as follows:

#### **3.4.1 Schools and Colleges**

The mainstream service provision of CCVEC is delivered through a network of 6-second level and further education colleges located in Cork City. These schools and colleges which are listed below provide a wide range of courses extending from Junior and Leaving Certificate to Further Education (Post Leaving Certificate). The wide range of courses on offer is designed to develop and enhance work skills and lifelong learning:

- College of Commerce, Morrison's Island, Cork
- St. John's Central College, Sawmill St., Cork

**(i) Oideachas Príomhshrutha**

**(i) Mainstream Education**

CCVEC provides a wide range of courses at second-level for the younger generation leaving primary schools. The mainstream provision comprises Junior Certificate, Leaving Certificate (including Applied Leaving Certificate) and Repeat Leaving Certificate. Almost 800 students are registered in 4 schools/colleges across the city.

**(ii) Further Education (Post-Leaving Certificate)**

Post Leaving Certificate Courses (PLC's) were introduced on a national basis in 1985. This is a major programme with over 4,000 students attending courses in 3 CCVEC colleges and two PLC units attached to second level schools (Nagle Community College and Terrence MacSwiney Community College).

Courses include Art & Design, Business Studies, Catering & Tourism, Communications, Media and Performing Arts, Health, Community and Childcare, Leisure/Recreation and Technology. Courses in Business Studies include Accounting, Marketing/Finance, Information Technology, Secretarial and International Teleservices, while courses in Technology include Applied Science,

Tá an fás ar an gclár seo inchurtha i leith chaighdeán na gcúrsaí a fhreagraíonn do riachtanais fostáiochta/oiliúna an réimse. Tá naisc láidre forbartha le fostóirí agus cuidíonn siad seo le hábharthacht na gcúrsaí a chinntiú. Cuidíonn ardchaighdeán deimhniúcháin le soghluaisteacht na mac léinn a áisiú.

### (iii) **Oideachas Aosach**

Tá tuiscint ag fás gur chóir don oideachas leanúint ar feadh an tsaoil agus go bhfuil leas ár sochaí agus ár gcumhacht eacnamaíoch ag brath ar leanúnachas an tsoláthair seo. Tá cúrsa oideachasúil tógtha ag an gcuid is mó de dhaoine nó bhíodar bainteach le foghlaim struchtúrtha éigin ó d'fhágadar an scoil nó coláiste. Tá breis agus 8,000 cúrsa páirtaimseartha reachtáilte in Éirinn gach bliain ag níos mó ná 1,000 scoil, coláiste agus grúpa agus meastar go bhfreastalaíonn suas le 200,000 aosach ar na cúrsaí seo.

The growth of the programme is attributable to the quality of the courses which match the employment/training needs of the area. Strong links have been developed with employers and these help ensure the relevance of courses. High quality certification helps to facilitate mobility of students.

### (iii) **Adult Education**

There is a growing perception that education should continue throughout life and that the wellbeing of our society and our economic strength need this continuity of provision. Most people have taken an educational course or engaged in some structured learning since leaving school or college. Each year over 8,000 part time courses are run in Ireland by over 1,000 schools, colleges and groups and it is estimated that up to 200,000 adults attend these courses.

CCVEC offers an extensive range of adult education courses to people of all ages for leisure, career improvement, and self-development. These courses are available to adult learners at in five of the VEC's colleges. In addition, a wide range of courses are provided through Local Area Networks in the city (see Community Education). Information on adult education courses is contained in CCVEC's "Guide to Courses & Services" which is published annually, through college brochures and from the VEC's website. Programmes offered range from leisure courses to programmes designed

**(iv) Oideachas Pobail**

Soláthraíonn CGCC réimse de chláracha oideachais pobail tríd na cathrach. Tá na cláracha seo á mbainistiú ag dhá oifigeach oideachais d'aoساigh agus tacaíocht acu ó áisitheoir oideachais pobail amháin. Chuir an Roinn Oideachais agus Eolaíochta €571,000 ar fáil do CGCC i 2006 chun Clár Oideachais Pobail a sheachadadh, trí ghrúpaí áitiúla atá eagraithe dá réir i ndeich "Líonraí Áitiúla Logánta". Tá gach líonra oscailte do na soláthróirí oideachais Pobail sa cheantar sainithe. Tríd an mheicníocht seo, tá foghlaimeoirí agus soláthróirí bainteach chomh maith i bpleanáil agus seachadadh na seirbhísí Oideachais Pobail d'Aosaigh sa chathair. Soláthraíonn Comhar Cathair Chorcaí maoiniú chomh maith chun cumasú do rannpháirtithe dul chun cinn a dhéanamh ó chláracha bunleibhéal go foghlaim chreidiúnaithe. I measc na

to enhance career opportunities and self-development programmes. Total annual enrolment on adult education courses run by CCVEC is of the order of 4000.

**(iv) Community Education**

CCVEC provides a range of community education programmes throughout the city. These programmes are managed by two adult education officers and supported by one community education facilitator. The Department of Education and Science provided €571,000 to CCVEC in 2006 to deliver its Community Education Programme, through local groups who are in turn organised into ten "Local Area Networks". Each network is open to all Community education providers in the defined locality. Through this mechanism learners and providers are also involved in the planning and delivery of Adult Community Education services in the city. Cork City Partnership (Comhar Cathair Chorcaí) also provides funding to enable participants progress to accredited learning from basic Foundation level programmes. Programmes include drama, health and fitness, personal development, music, creative writing together with many other options. Community education is non-threatening and non-judgemental. Learning support for the participant is central to every programme. CCVEC's Adult Guidance Service is available to assist any adult attending or planning to attend basic education programmes in the city.

**(IV) Vocational Training Opportunities Scheme (VTOS)**

### Scéim Deiseanna Oiliúna Gairmoideachais (SDOG)

Soláthraíonn an Scéim Deiseanna Oiliúna Gairmoideachais (SDOG), a tugadh isteach don chéad uair i 1989 deis d'aosaigh atá difhostaithe go fadtéarmach filleadh ar oideachas lánimseartha agus tugtar "seans eile/athdheis" dóibh. Is gá d'aosaigh a bheith os cionn 21 bliana d'aois agus difhostaithe ar feadh ar a laghad 12 mí.

Tugann an clár seo deis d'aosaigh a d'fhág cúrsaí oideachais go luath tógail ar a gcuid bunscileanna, a chuimsíonn léitheoireacht, scríbhneoireacht agus scileanna teicniúla. Bogann mórlach na mac léinn ar na cúrsaí seo ar aghaidh go dtí an Ardteistiméireacht nó cláracha bunaithe ar scileanna speisialta.

Dhá mhodh ar fáil -

- **Croí-Mhodh:** Is mic léinn SDOG go heisiach iad ar fad
- **Modh Scapthe:** Tá na mic léinn "measctha" le mic léinn eile, e.g., ar chúrsaí iar-Ardteistiméireachta (PLC)

The Vocational Training Opportunities Scheme (VTOS), which was first introduced in 1989 offers long-term unemployed adults the opportunity to return to full-time education and gives them a "second chance". Adults must be over 21 years of age and unemployed for at least 12 months.

This programme offers adults who have left education early an opportunity to build up their basic skills, including reading, writing and technical skills. The majority of students on these courses move on to leaving certificate or special skills programmes.

Two modes are available -

- **Core Mode:** All students are exclusively VTOS
- **Dispersed Mode:** Students are "mixed" with other students, e.g., on PLC courses

On this VTOS programme, adults continue to receive their social welfare benefits which are paid through CCVEC. Books are provided on a loan basis to students. A meal and travel allowance may also be provided. Unemployed adults are also encouraged to pursue Post-Leaving Certificate Courses. The number of places on the VTOS programme in 2005/2006 was 450

### 3.4.2 Ionaid Eile

#### (a) Ógtheaghmháil

Tá Ógtheaghmháil mar chlár náisiúnta oideachais athdheise agus oiliúna in Éirinn. Déanann sé freagra náisiúnta a chomhlíonadh ar na riachtanais atá ag lucht luathfhágála neamhcháilithe scoile agus cuireann sé clár comhtháite oideachais ginearálta, oiliúint ghairme agus taithí oibre ar fáil. Tá cláracha soláthraithe leis an Teastas Sóisearach, an Ardteistiméireacht agus dámhachtainí FETAC mar mhórsprioc acu. Tá ábhair na gcúrsaí foghlaimeoir-lárnaithe agus trialach le béim láidir ar ghnóthachtáil agus ar chumais na rannpháirtithe a forbairt. Tá sé mar aidhm ag na cláracha féin-luach agus céannacht na rannpháirtithe a chur chun cinn chomh maith le bród ina gcuid ábaltachtaí agus ina gcuid oibre.

Tá 4 ionad Ógtheaghmhála á reachtáil ag CGCC sa chathair. Tá na hionaid lonnaithe ag Dean St, An Gleann, Knocknaheeny agus i lár na cathrach. Tá na hionaid lonnaithe

### 3.4.2 Other Centres

#### (a) Youthreach

Youthreach is part of a national programme of second-chance education and training in Ireland. It fulfils the national response to the needs of unqualified early school leavers and offers a programme of integrated general education, vocational training and work experience. Programmes are provided leading to Junior Certificate, Leaving Certificate Applied and FETAC awards. The course subjects are learner centred and experimental with a strong emphasis on achievement and on developing the capacities of the participants. The programmes seek to promote the participants self-worth and identity as well as pride in their abilities and work.

CCVEC, operates Youthreach 4 centres in the city. The centres are located in Dean St, The Glen, Knocknaheeny and City Centre. The centres are located in "out-of-school" premises. Currently CCVEC caters for 150 learners on this programme.

#### (b) St. Finbarr's Senior Traveller Training Centres

St. Finbarr's Senior Traveller Training Centre which is based in Blackpool is a co-education centre for young travellers and offers Junior Certificate, Leaving Certificate Applied, second chance education and vocational training.

**(b) Ionad Oiliúna Naomh Fionnbarra do Thaistealaithe Sinsearacha**

**(c) Litearthacht Aosach**

Is mórsoláthróir é CGCC do litearthacht aosach. Baineann Seirbhís Litearthachta d'Aosaigh CGCC riachtanais litearthachta amach trí chláracha ardchaighdeáin atá mac léinn-lárnaithe a sholáthar i 9 scéim litearthachta mórthimpeall na cathrach e.g. Mahon, An Gleann, Churchfield, Togher, srl

Baineann beagnach 1,100 aosach úsáid as an tseirbhís i scéim CGCC. Tá teagasc ar fáil i réimse suíomh cosúil le Coláistí CG, Ionad Oideachais d'Aosaigh atá Pobal-Bhunaithe, Ionad Dífhostaíochta agus i gcomhoibriú leis na múinteoirí Teaghála Baile Is Scoile sna bunscoileanna agus iarbhunscoileanna araon.

**(d) Seirbhís Oideachais do Phríosún**

**(c) Adult Literacy**

CCVEC is a major provider of adult literacy. CCVEC's Adult Literacy Service meets literacy needs by providing high quality student centred programmes in the 9 Literacy schemes throughout the city e.g. Mahon, The Glen, Churchfield, Togher, etc

Approximately 1,100 adults avail of the service in CCVEC scheme. Tuition is available in a variety of settings such as VEC Colleges, Community Based Adult Education Centres, Unemployment Centres and in co-operation with Home School Liaison teachers in both primary and secondary schools.

**(d) Education Service to Prisons**

CCVEC provides a comprehensive education service in Cork Prison ranging from basic education level to FETAC/Junior Cert/Leaving Cert, ECDL, MOS and degree level (Open University). There is a strong emphasis on literacy and creative arts e.g., art, music, drama, writing etc. A great deal of expertise and resources has been built up over the years by teachers and a number of publications have been produced based on the work of both students and teachers. Teacher support comprises 20 whole-time teacher equivalents. The Dillon's Cross Project is an outreach initiative of CCVEC's Education Service to Prisons. Its aim is to facilitate the re-integration of ex-prisoners.

Cuimsíonn tacaíocht an mhúinteora de leibhéal atá inchurtha le 20 múinteoirí lánaimseartha. Is Tionscnamh For-Rochtana de Sheirbhís Oideachais do Phríosún CGCC é Tionscadal Cros Uí Dhiolúin. ### 3.4.3 Internal Support Units

The Chief Executive Officer is responsible for the educational, management and administrative functions of CCVEC as illustrated in the core structure of the chart at the end of this chapter.

The Chief Executive Officer is supported by two Education Officers, a Head of Administration (Principal Officer), four Assistant Principal Officers, college Principals and the Heads of Centres. The core functions are described as follows:

#### Education

The education function incorporates the provision of scheme-wide services in such areas as the planning, co-ordination, development, implementation and evaluation of course programmes and related services, allocation and monitoring of resources, in-service training and liaising with external bodies.

#### Finance

The finance function is responsible for the management and control of CCVEC's finances, the implementation of budgetary control procedures, management accounting and the preparation of annual accounts. The finance function is responsible for managing CCVEC's annual budget of €50m.

### Human Resources

The Human Resources function is responsible for staff recruitment, selection and induction, employee records, industrial relations, employee welfare, pension administration, special cases and the preparation and implementation of staff policies and procedures. CCVEC currently employs over 1,500 staff (full-time & part-time) at different levels and grades.

### Education Support

The Education Support function is responsible for education/management support, management of CCVEC's building and support activities which cover some 12 premises across the city and processing the scholarship/grants Scheme. The function is also responsible for new building programmes, liaising with external consultants, public tendering and liaising with the Department of Education and Science and other external bodies.

### ICT

The ICT function is responsible for developing and managing CCVEC's IT services. This includes responsibility for developing and maintaining critical software applications and management information systems, carrying out special projects and assignments and providing advisory services to central and local management on IT and related matters.




#### 4.1 Cúlra

## Chapter 4

### Enhancement of Services to be provided bilingually

#### 4.1 Background

CCVEC is committed to providing by the end of the proposed scheme an appropriate number of staff competent to deliver a service through the Irish language in its colleges, other centres and internal support units. The primary deliverable will be the progressive development of a quality one-to-one customer service in Irish for its colleges, other centres and internal support units not currently in a position to provide such a service. In this context, the Committee will have a full bilingual counter service available bilingually by September 2009 in all its centres.

#### 4.2 Staff Training and Development

- Human Resources will, where appropriate, put reasonable measures in place to ensure that an appropriate number of staff, with a proficiency in the Irish language will be available in order to comply with the provisions of the Official Languages Act.
- CCVEC will provide relevant training courses with the objective of meeting the needs of its staff with regard to the Irish language requirements of its schools, colleges,

other centres and internal support units in accordance with the Official Languages Act 2003. The primary aim of this initiative will be the progressive development of a quality one-to-one service in Irish for all CCVEC colleges, centres and internal support units.

- Voluntary training in spoken Irish will be put in place for Head Office Staff by January 2007 and will be extended to Staff in other Colleges/Centres by September 2007. Attendance at other Irish Language courses will be encouraged and assisted.
- Training courses will be provided on an ongoing basis and will be subject to regular review. Consideration will be given to implementing incentive schemes, such as an awards scheme for staff attending Irish Language training courses or a staff support scheme for attendance on Irish courses in the Gaeltacht.

#### 4.3 Recruitment & Placement

The following measures will be put in place by the HR Department in order that an adequate number of staff with proficiency in the Irish language are recruited and retained within the Committee to comply with the provisions of the Act:

- In September 2008 the HR Section will review the proficiency of Irish achieved by staff within each Section.

- Following this review, appropriate placement of staff with such proficiency will be implemented throughout the Committee were possible and appropriate. This policy will optimise the availability of services through Irish.
- If, as a result of this review, it would appear unlikely that the Committee can provide sufficient staff proficient in Irish from within its own staff, A recruitment policy will be implemented which, over the following five years, will require proficiency in Irish to be an essential requirement for a number of posts within the Committee.
- Complementing the above, staff with a working knowledge of Irish will be appropriately placed across various Centres/Colleges to support the commitments set out in this Scheme

#### 4.4 Improving CCVEC's Irish Language Capability

The following actions are proposed in order to ensure that both the level and standard of services to the public are improved over the duration of the scheme:

- Efforts will be made to ensure that a sufficient number of staff with relevant competence in the Irish language will be available across CCVEC. A survey/questionnaire will be conducted in our colleges and other centres with a view to compiling a register of those competent in the Irish language as set out in our Customer Service Action Plan.

- Staff responding to queries in the Irish language will comply fully with our revised Customer Service Action Plan. The CCVEC's current Customer Service Action Plan does not specifically provide for Irish language queries but this will be amended for 2007 to take account of the actions proposed in the Committee's Scéim Teanga.
- CCVEC through its HR Department and with the co-operation of Principals and Head of Centres will create opportunities for providing, relevant and regular in-service courses for staff in the Irish language. These courses will be subject to regular review.
- The Official Languages Advisory Group will provide assistance to the CEO and senior management including Principals and Heads of Centres with the implementation of the Official Languages Act 2003.
- CCVEC Management will play an important role in positively encouraging more use of Irish in various ways e.g., using more Irish greetings, encouraging both internal and external customers with an interest in Irish to complete forms etc in Irish.
- A bilingual leaflet of key services, available under CCVEC's Official Languages Act Scheme, will be visibly displayed in every centre and distributed to the public as part of CCVEC's publicity material.
- CCVEC in line with its Customer Service Action Plan will inform its customers of their right to choose to be dealt with through one or other of the official languages.
- Over the 3 years of the scheme, a bilingual telephone answering service will be implemented in all schools, colleges, and other centres throughout CCVEC's scheme.

- Cuirfidh CGCC in iúl dá gcustaiméirí, ag teacht lena bPlean Gníomhúcháin Seirbhíse do Chustaiméirí, an ceart atá acu rogha oibre a dhéanamh maidir le ceann amháin nó eile de na teangacha oifigiúla.

#### 4.3 Polasaí na gCruinnithe Poiblí

Déanann CGCC mórlach na gcruiinnithe poiblí a bhíonn acu a stiúradh i mBeárla amháin. Cibé ar bith, déanfaidh siad aon chruinnithe poiblí ar cheisteanna a bhaineann le teanga na Gaeilge sa todhchaí a stiúradh trí Ghaeilge, nó trí Ghaeilge le haistriúchán comhuaineach go Béarla, cibé rogha a cheaptar a bheith oiriúnach.

- CCVEC will issue corporate publications in both the English and Irish languages.

#### 4.5 Public Meetings Policy

CCVEC conducts the majority of its public meetings in English only. However, it will conduct any future public meetings on Irish language issues through Irish, or alternatively through Irish with simultaneous translation to English, whichever is considered appropriate.
