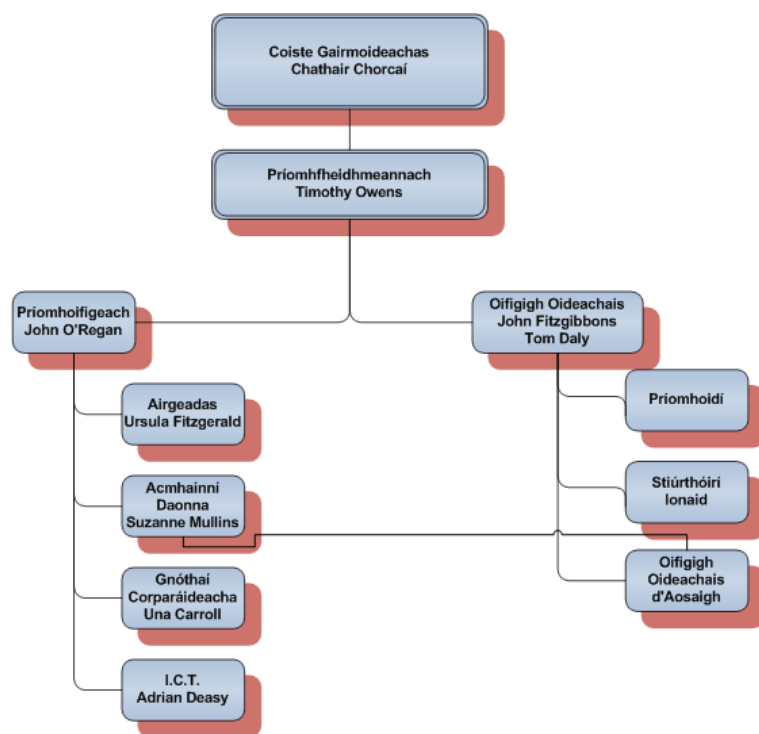

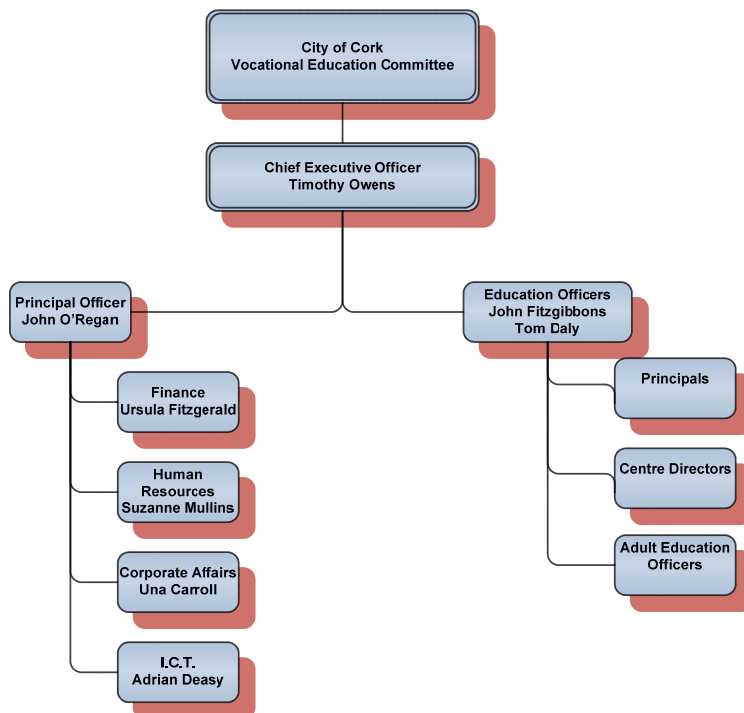
### ORGANIZATIONAL STRUCTURE AND RESPONSIBILITIES

#### THE ROLE OF THE VEC

The committee is comprised of thirteen members who are nominated directly by Cork City Council. Two members are elected by the staff of the City of Cork VEC and two members are elected by the parents of students of the City of Cork VEC. (The two parent representative places are currently vacant. The functions of the committee which are “Reserved Functions” under the Vocational Education Amendment Act (2001) include: policy development, planning, monitoring, and the adoption of the annual report and accounts. The Committee is also responsible for the appointment of its Chief Executive Officer.

#### CORPORATE GOVERNANCE

The City of Cork VEC has, in accordance with the requirements of the Department of Education and Science Circular Letter F11/05, adopted a Code of Best Practice for Corporate Governance. This Code ensures that the principles of good governance are applied by the Committee and its officers in individual and collective roles and areas of responsibility.

While the Chief Executive Officer has overall responsibility for the administration of the Committees business, the day to day administration function is the immediate responsibility of the Principal Officer. The Committees administrative functions are divided into four main areas:

Each administrative area or department is overseen and coordinated by an Assistant Principal Officer.

**The Finance Department** is responsible for controlling and monitoring the VEC's Finances. Its responsibilities and remit includes:

### **Information and Communications Technology Department**

While the ICT department is the smallest in terms of personnel within the VEC organization, its remit and responsibilities are extensive. The department is responsible for ensuring that the ICT hardware, software and facilities across the scheme support the delivery of efficient data services to all VEC staff and clients. The ICT department has focused on the development of an ICT strategy that will ensure the stability of critical systems, ensure data integrity and allow the integration of all data services under a common framework. Key to this has been the management of a range of data services to support the Finance, Human Resource and Student Support functions of the Committee.

The ICT department is also responsible for:

- Technical support and advice to colleges/centres
- Staff ICT training

**The Educational Support Service** covers three main areas:

- Estate Management.

Corporate Support operates the VEC reception & switchboard and provides secretarial services to the Committee & Sub Committees, the CEO, Education, Adult Education and Youth Officers and the Community Education Facilitator. It also has responsibility for customer service and Freedom of Information requests and procedures.

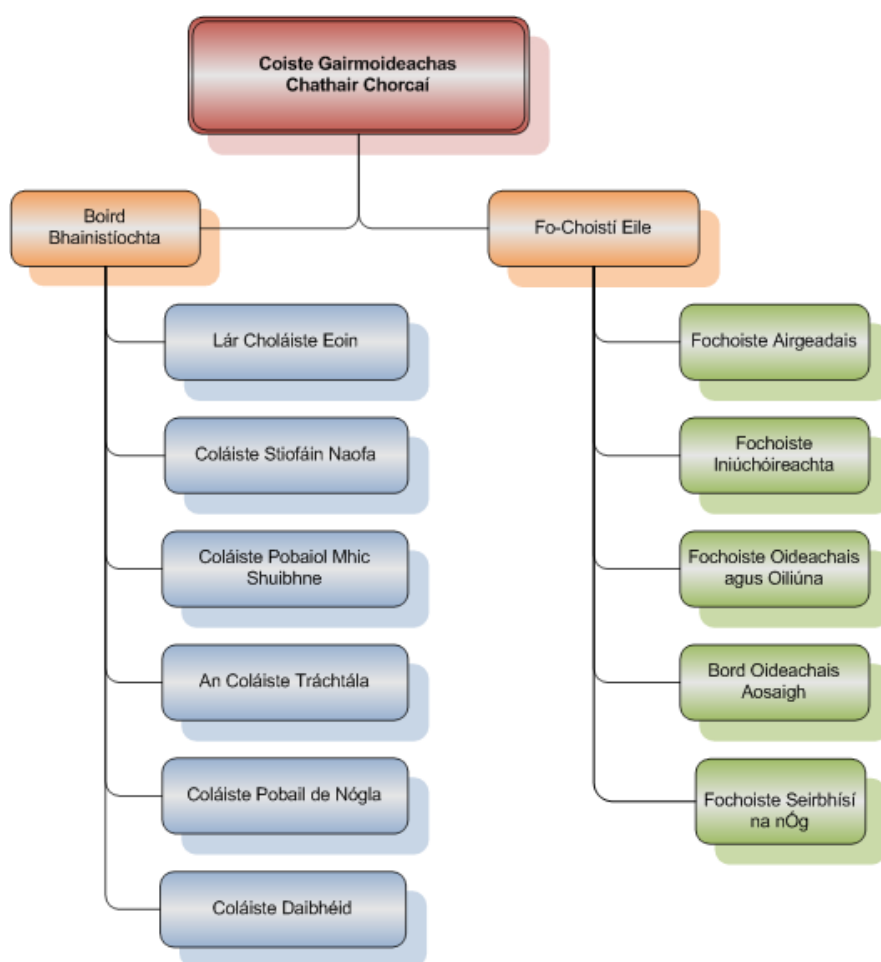

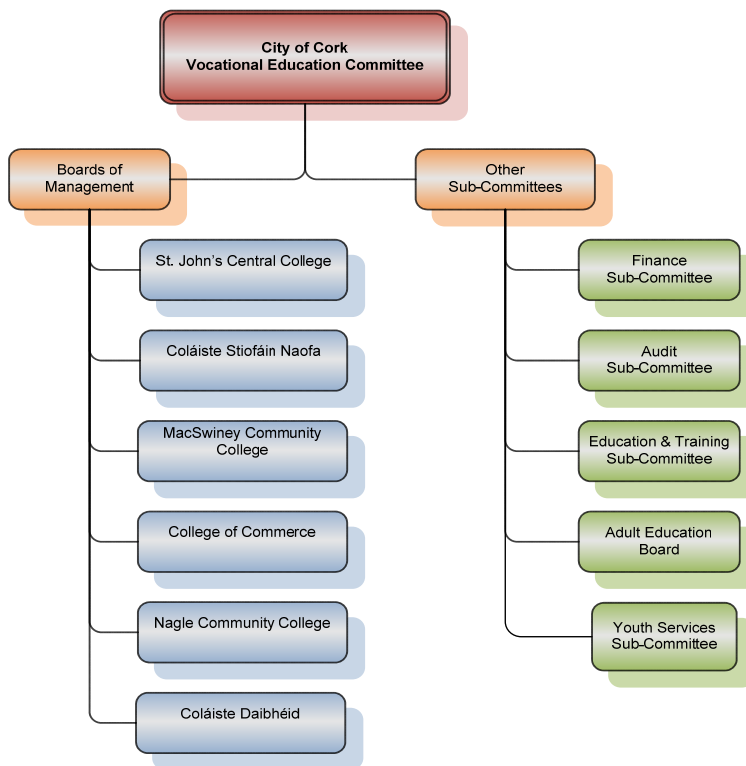

## SUBCOMMITTEES OF THE VEC

The City of Cork VEC has, in accordance with the provisions of Education Act (1998) and the Vocational Education Amendment Act (2001), established a number of sub-committees to support the Committee in meeting its responsibilities and to provide effective and responsive leadership and management throughout the services of the VEC



### Boards of Management

Boards of Management have been established for each of the VEC's schools and colleges, in accordance with the requirement of the Education Act 1998. The Principal acts as Secretary to the Board of Management and the membership of each board is representative of the stakeholders in the individual centre. In response to the unique

### Education and Training Sub-Committee

The City of Cork VEC has three Youthreach Centres under its jurisdiction and a Senior Traveller Training Centre. ### Youth Services Sub-Committee

## Finance Report 2007

### Income & Expenditure 2007 Overview

Income and expenditure are recorded on a cash receipts and payment basis.

#### Income

Income in 2007 was €59,813,485. This represents a 12.84% increase on the previous year.

#### Expenditure

##### *Pay*

The pay element of this Committee's expenditure represents 64.09% of the overall expenditure. Pay costs increased by 1.46% in 2007. The increase in pay reflects the impact of pro-rata (workers protection) legislation, national pay awards and increments.

A total of 1,577 employees were recorded on the P.35 tax return at year (1,481 in 2006). There were no significant increases in staffing levels in 2007.

##### *Non Pay*

Overall non pay recurrent costs in the 2007 financial year were generally at the same level as the previous year.

Main Scheme non-pay expenditure increased by €312,596 in 2007. This increase was due mainly to increased costs in all service provision areas, with the increased costs of general services and utilities accounting for a significant proportion of the increase.

#### Student payments

##### *VTOS*

A total of 453 students were paid allowances in lieu of Social Welfare payments in 2007. This number is consistent with previous years.

##### *Youth Reach/Travellers/BTEI*

Up to 168 students were paid trainee allowances in 2007. This figure represents a marginal increase on previous years.

##### *Post Leaving Certificate Support*

A total of 1,007 students were paid maintenance grants in 2006, a decrease 125 of or 11% over 2006. The majority of students in receipt of these payments are resident in Cork City or County Cork.

The VTOS (Vocational Training Opportunities Scheme) operates through "dispersed mode" provision in the colleges, allowing second chance education opportunities to be provided for learners in receipt of social welfare.

As this data shows, overall enrolments declined in Nagle Community College by almost 5% year on year, notwithstanding an increase in Post Leaving Certificate enrolments at the college. Terrence MacSwiney Community College shows an increased enrolment of almost 11%, all in the post primary section of the college. Coláiste Daibheid evidenced a 4.3% increase in enrolments and indications are that this is likely to be maintained in the coming years.

Overall, Post Leaving Certificate enrolments have declined by a further 2.7%, with the College of Commerce showing a continued decline in enrolments of 5.5%.

Enrolments are likely to continue to pose one of the greatest challenges for the Committee in the year ahead, with Nagle Community College and the College of Commerce being of most concern. A consequence of falling PLC enrolments during in the year was a reduction in the allocation of approved places from the Department of Education and Science to the Committee. Unless the trend which has persisted for several years is reversed, a significant staffing over-allocation situation will emerge in coming years.

## Youthreach Centres

The Committee is directly responsible for the operation of four Youthreach Centres and one Senior Travellers Training Centre. The location and size of these centres was determined in close consultation with FAS which provides for parallel opportunities in a number of Community Training Centres within which the Vocational Education Committee provides certain teaching services. A review of the Committee's activities in this area has commenced to ensure that current provision matches the changing needs of the target group and having due regard to related initiatives and legislative developments, including the Education (Welfare) Act.

The centres provide Junior Certificate, Leaving Certificate Applied (LCA) and FETAC programmes to young people between the ages of 12-19. Students are referred to the service by the Education Welfare Board, the Health Board and the schools of Cork City.

The Youthreach centres have continued to engage throughout 2007 in the implementation of the Quality Framework Initiative for Youthreach and Senior Traveller Training Centres. Through Centre Development Planning, Internal Centre Evaluation and External Centre Evaluation, a coordinated approach to improving the quality and appropriateness of interventions for young people has been implemented.

## Seirbhís Oideachais Phríosún Chorcaí

---

## Education Service Cork Prison

---

The Committee began providing an education service to Cork Prison in 1978 on a part-time basis initially and has expanded to keep pace with the increase in prisoner population.

A purpose built education unit was constructed in 1983, with specialist art, woodwork, and home economics classrooms. The student population is an exclusively male one, the vast majority of which would have left the formal education setting with no accreditation, and would have had problematic and difficult lives. Education opportunities are made available to all prisoners on their entry to the prison; uptake is variable, with continuity a particular problem due to the transient and variable nature of the prison population.

The following Programmes are offered and delivered within the Prison Education Service:

- Junior Certificate
- Leaving Certificate
- FETAC
- Open University

347 prisoners participated in education programmes during the 2007 year.

A post-release programme operates in conjunction with the Probation Service for offenders on their release from prison. It offers opportunities under both FETAC and BTEI programmes:

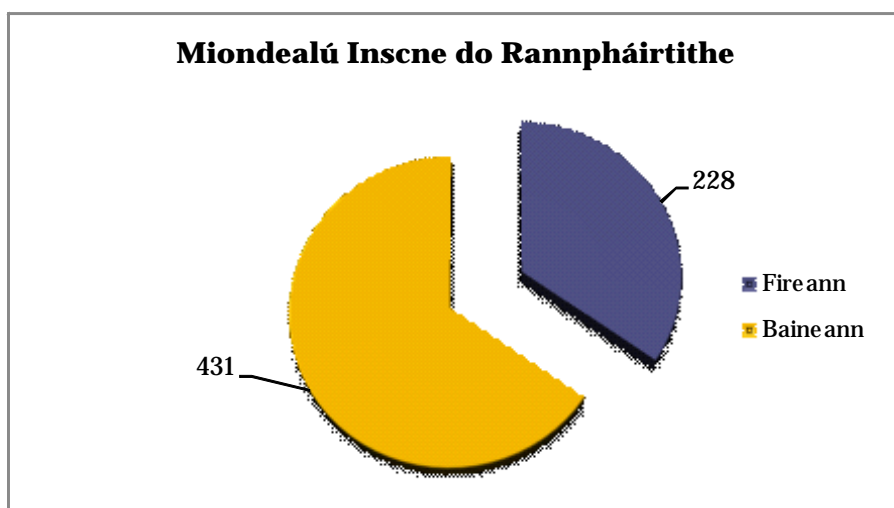

## An Tionscnamh um Fhilleadh ar an Oideachas (BTEI)

Is clár páirtaimseartha é an Tionscnamh um Fhilleadh ar an Oideachas ina ligtear do dhaoine óga agus do dhaoine fásta pilleadh ar oideachas a cheangal lena gcuid dualgas teaghlaigh agus eile. Cuirtear BTEI ar fáil trí réimse seirbhísí CG, ina measc Coláistí Breisoideachais, seirbhís Oideachais Phobail agus an tseirbhís Bunoideachais um Dhaoine fásta (Litearthacht).

Cuireadh leithdháileadh de €468,224 ar fáil i 2007 faoin gclár seo. Mar gheall ar sholúbthacht an chláir ligeadh do na seirbhísí soláthraithe réimse clár solúbtha agus nuálach a fhorbairt do 659 foghlaimeoir.

As na foghlaimeoirí a soláthraíodh dóibh, fir ab iad 34.6%. Sin feabhsú suntasach thar bhlianta roimhe sin ( i 2006, an figiúr coibhéiseach ab ea 19.55%). D'ainneoin an méid seo, tá deacrachtaí leanúnacha a mhaireann chun fir a mhealladh chun páirt a ghlacadh i gcúrsaí oideachais, go háirithe fir óga.



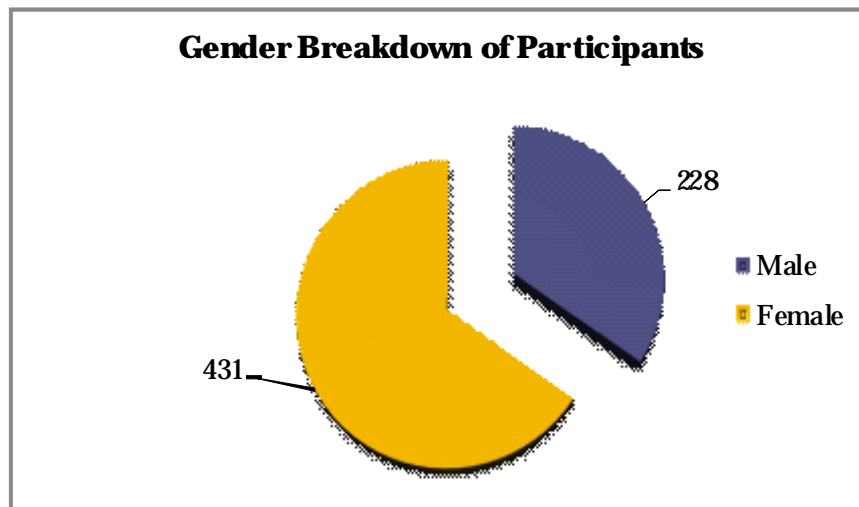

## Back to Education Initiative (BTEI)

The Back to Education Initiative is a part-time programme that allows young people and adults to combine a return to education with their family and other commitments. BTEI is provide through a range of VEC services, including the Further Education Colleges, Community Education service and the adult Basic education (Literacy) service.

An allocation of €468,224 in 2007 was provided under this programme. The flexibility of the programme allowed the proving services to develop and deliver a range of flexible and innovative programmes to 659 learners.

Of the learners provided for, 34.6% were male. This is a significant improvement over previous years (2006 the equivalent figure was 19.55%). Notwithstanding this, there are continuing difficulties experienced in engaging men, particularly young men, in education.



Of the participants, over 71.97% had less than upper second level education, with 24% describing their previous education experience as Primary or below.

## Young Peoples Facilities and Services Fund

---

The Young Peoples Facilities and Services Fund was established in 1998 as part of the Government's overall strategy to tackle drug misuse. The Fund aims to assist in the development of youth facilities, including sport and recreational facilities and services in disadvantaged areas where a significant drug problem exists or has the potential to develop.

The objective of the Fund is to attract "at risk" young people in disadvantaged areas into these facilities and activities and divert them away from the dangers of substance abuse. The target groups for the Fund are 10-21 year olds who are marginalized through a combination of risk factors relating to family background, environmental circumstances, educational disadvantage, involvement in crime and/or drugs, etc. The main focus of the Fund to date has been in Local Drugs Task Force areas.

The Knocknaheeny Youth Link-Point, on the grounds of Terence McSwiney Community College, (a City of Cork VEC institution) was officially opened by Minister of State Pat Carey in November.

The Youth "Link- Point" is part of a complex of new buildings on this site, comprising also a Family Crèche, operated by the Daughters of Charity and a Springboard Project, operating under the aegis of the Health Service Executive.

The primary purpose of the Knocknaheeny Youth "Link-Point" Service is to provide contact, orientation and linking onwards for local young people - particularly for those who are not participating in existing Services. It was developed at a cost of €542,500.

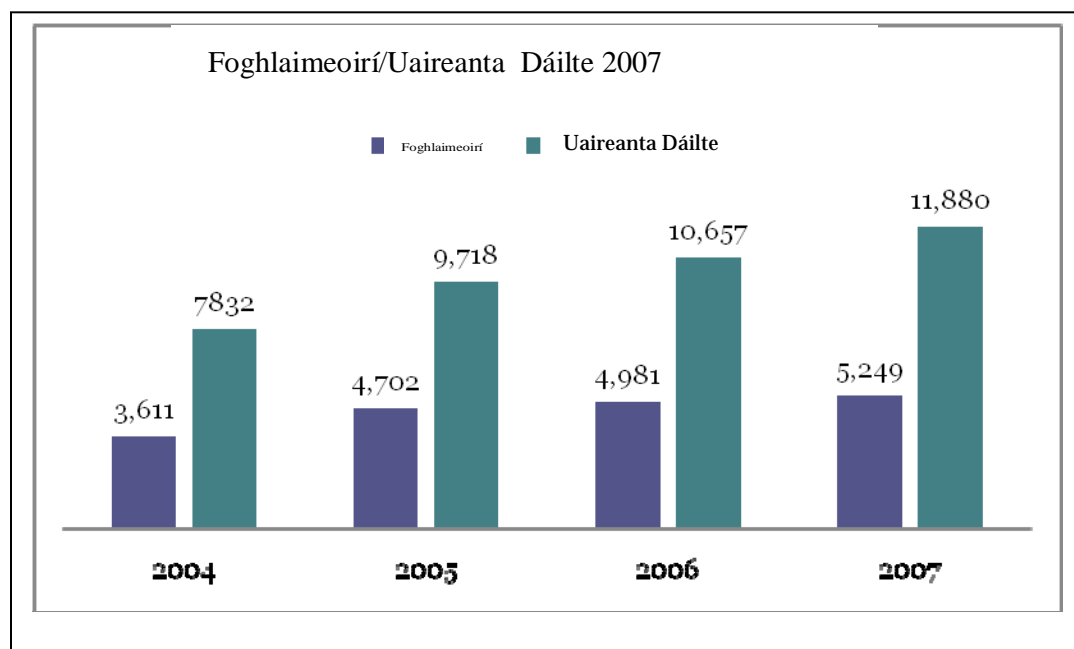

## Community Education

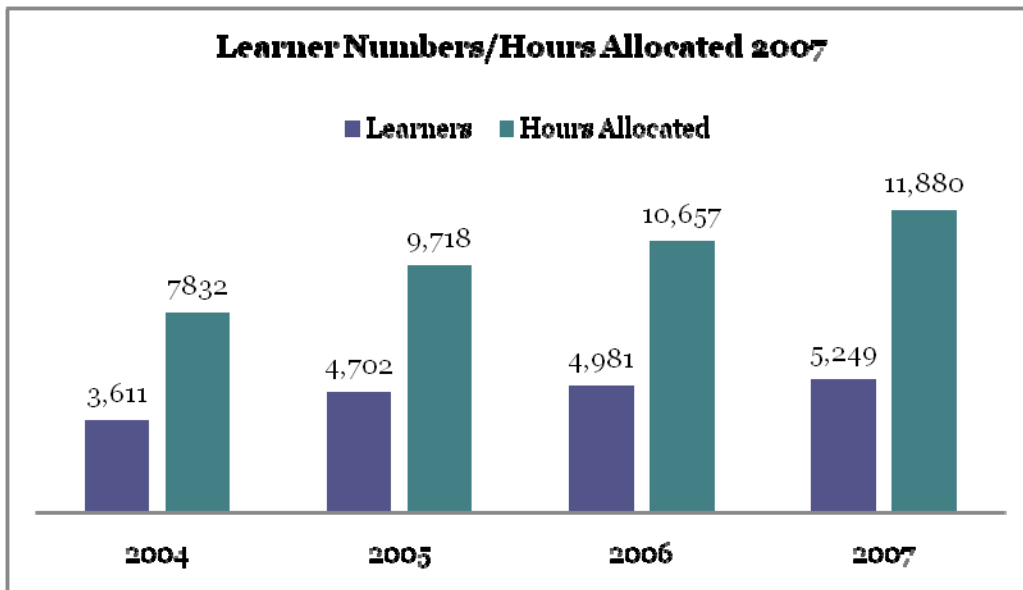
### Summary of outcomes in 2007

The Community Education Service of City of Cork VEC (CCVEC) is delivered through a partnership with a committed pool of 102 community based providers throughout the city.

The structure of the service has remained in keeping with the Structured Progression Model, which is the rationale underlying the CCVEC Community Education Strategy. Adult Literacy & Community Education (ALCE) funding remains largely targeted at Stage 1 learners, while Back to Education Initiative (BTEI)/Cork City Partnership (CCP) funding is specifically focused on Stage 2 of the Structured Progression Model,

In 2007 the service experienced another year of steady growth.

- Numbers participating (all three streams) was 5,249 in 2007, up from 4,981 in 2006.
- The ratio of certification (across all three funding streams) was 36% of 432 courses in 2007 down slightly from 38% of 430 courses in 2006.

### Adult Literacy and Community Education (ALCE) Funded Community Education (Primarily Targeting Stage 1 Learners)

- In 2007 funding from ALCE increased to €381,524 from €336,690 in 2006.
- Despite a rise in tutor pay, the number of hours increased by 841 over the 2006 level.
- The number of individual learners benefiting increased to 4,429, up from 4,133 in 2006.
- The number of courses remained steady at 335, almost consistent with previous years, 334 in 2006 and 332 in 2005.
- The number of courses funded under ALCE offering certification decreased slightly in 2007 to 18% down from 21% in 2006.

### Back to Education Initiative (BTEI) and Cork City Partnership (CCP) funded Certified Community Education (exclusively targeting Stage 2 learners)

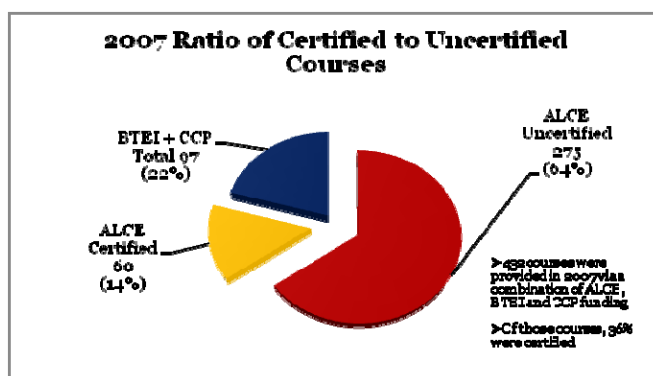
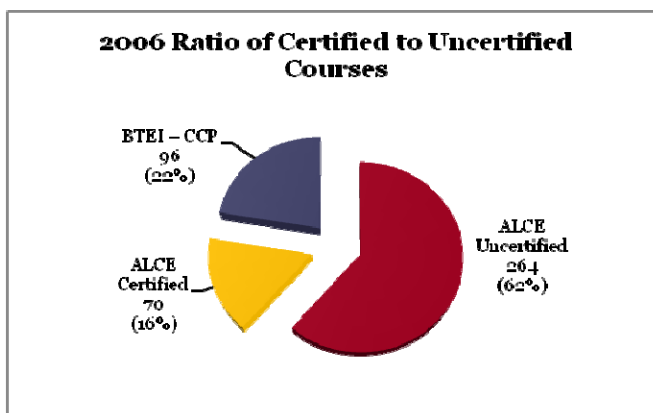
- The number of learners benefiting from these certified community education courses in 2007 declined slightly at 820 down from 848 in 2006.
- Funding from BTEI and CCP in 2007 was €146,120 an increase on €118,500 in 2006. This enabled the service not only to meet its increased tutor pay commitments but also to expand provision by almost 400 hours.
- The number of courses, which *all* lead towards certification, remains steady at 97 compared to 96 in 2006.
- The Service reached the specifically targeted groups, including in particular:
  - people with disabilities (who represent 43% of learners)
  - low income families
  - single parent families
  - Immigrants

### Overall picture of certification in Community Education

ALCE figures need to be combined with data from the BTEI/CCP certified courses to give the complete picture below.

When the number of certified courses funded under ALCE and BTEI/CCP are combined, the ratio of certification in the Community Education Service overall in 2007 was 36%. This represents a very slight decrease on 2006 when the ratio was 38% and the number of courses was lower.

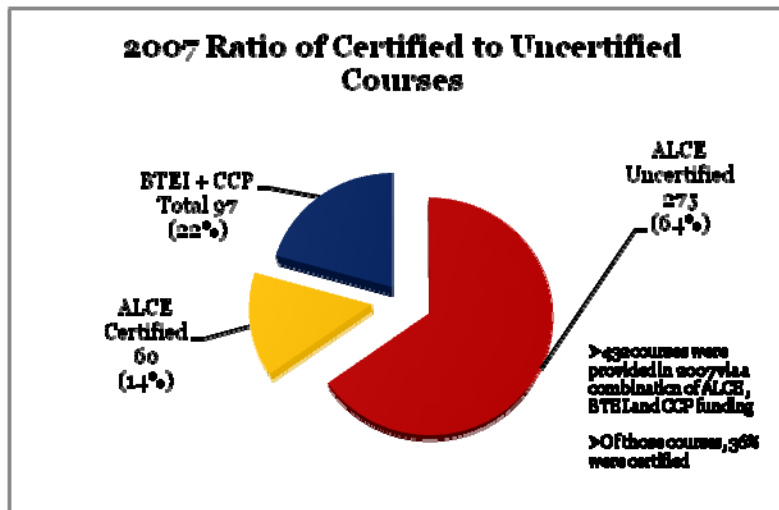
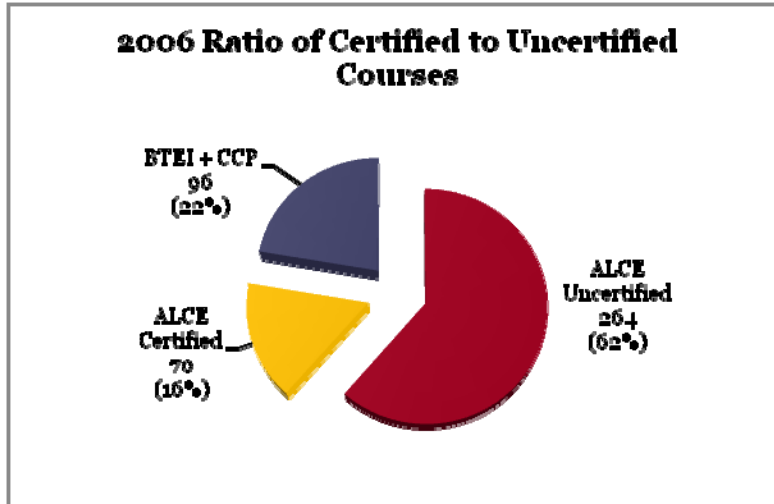

This ratio needs to be monitored and examined in the future in light of two emerging factors:

- The introduction of NQF Levels 1 and 2 by FETAC in 2007 will create opportunities in time for Community Education providers to offer certification at levels below the previous starting point, formerly known as NCVA Foundation level.
- The ongoing need to balance the number of opportunities to re-enter the education system through the uncertified Community Education service with the need to offer meaningful opportunities for individuals and groups wishing to progress educationally by gaining certification for their learning.

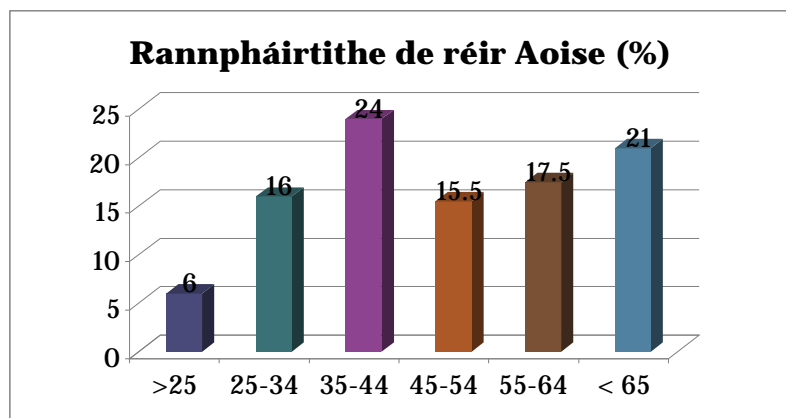
### Soláthar Cúrsa 2007

I 2007 sholáthair seirbhís Oideachais Phobail CG Chathair Chorcaí 335 cúrsa – beagnach an uimhir chéanna is a bhí ann i 2006. Bíonn na cúrsaí ar siúl go tipiciúil thar 10 go 12 seachtain, le seisiúin ranga de dhá uair in aghaidh na seachtaine.

### Na Foghlaimeoirí

Bhí ranganna Oideachais Phobail curtha ar fáil do 4,429 foghlaimeoir i 2007, in éagsúlacht chúrsaí, suas ó 4,133 foghlaimeoir i 2006. De na foghlaimeoirí seo, fir ab iad 821 dóibh agus mná 3,608. Tá taifead comhsheasmhach le blianta beaga anuas don chuid is mó ag baint le leibhéal íseal páirteachais fhir in Oideachas Aosaigh.

Tá an próifíl pháirteachais trasna gach grúpa aois, tuairiscithe ag soláthraithe a bhfuair cistiúchán Oideachais Phobail i 2007, ar taispeáin sa chart seo a leanas. Tá láithreach suntasach de dhaoine sna grúpaí d'aois níos sine, agus tá sé dóchúil go méadófar ar seo thar na deich bliana atá le teacht, bunaithe ar réamhaisnéisí déimeagrafaíochta reatha.



### 2007 Allocation and utilisation of hours

There was an allocation of 8,671 teaching hours, at a cost of approximately €381,524, provided through Family Resource Centres, Home School Community Liaison Schemes, Disability and Retired groups/organizations, Traveller Education Schemes and other community led initiatives.

Across the city 102 centres were allocated part time hours to meet the needs of their catchment area, or community of interest in the case of citywide services.

Of the 8,671 hours allocated, 93% were used. The shortfall is due to a variety of factors - for example, planned courses may fall through, sometimes late in the autumn, the main period of activity.

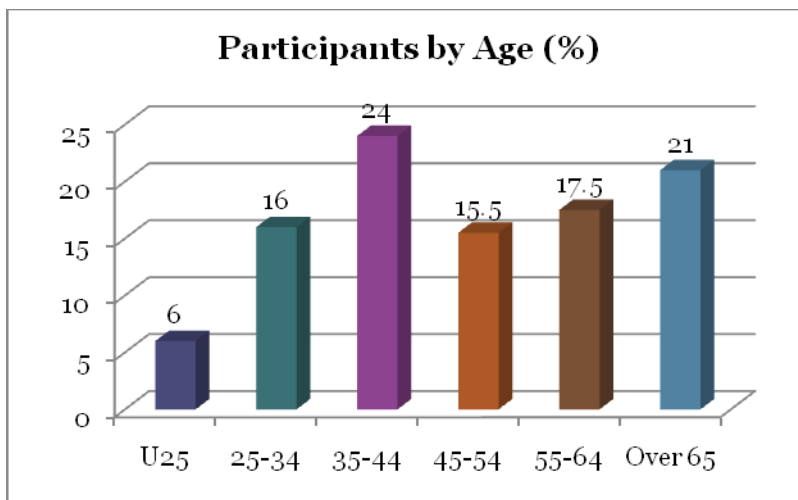
### 2007 Course Provision

In 2007 the City of Cork VEC Community Education service provided 335 courses – almost the same number as in 2006. Courses typically run over 10 to 12 weeks, with class sessions of two hours per week.

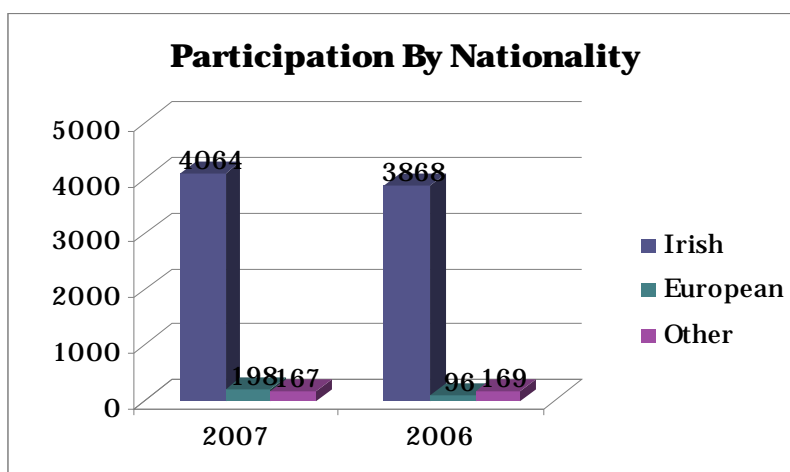
### The Learners

Community Education classes were provided for 4,429 learners in 2007, in a variety of courses, up from 4,133 learners in 2006. Of these learners, 821 were male and 3,608 female. The low level of male participation in Adult Education generally has been consistently recorded in previous years.

Participation profile across all age groups, reported by providers in receipt of Community Education funding in 2007, is shown in the following chart. There is a significant presence from people in the older age groups, with this likely to increase over the next decade based on current demographic forecasts.

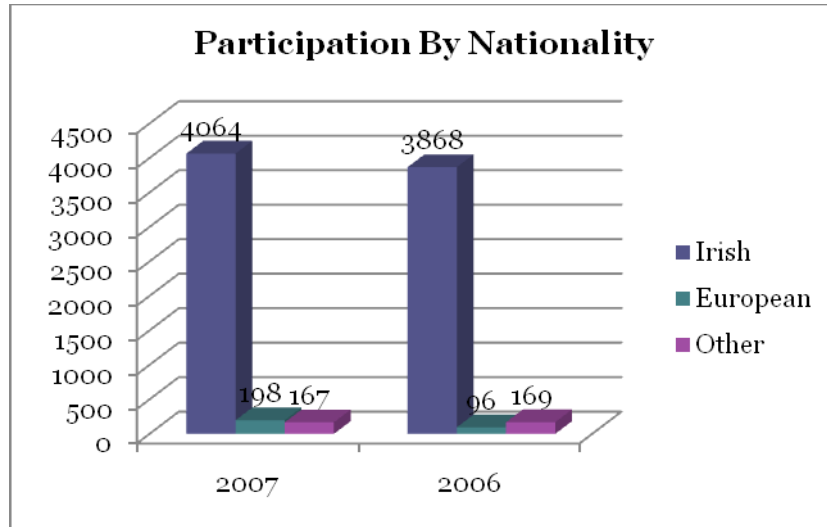

Bhí méadú go bhforiomlán sa bhuiséad de €27,620 i 2007. Tharla an méadú seo go príomha de bharr soláthair fhadaithe maoinithe ag BTEI. Dá bharr, bhí méadú sna huaireanta teagascóra dailte do chúrsaí deimhnithe faoi bheagnach 400, fad is a bhíothas fós ag sroicheadh rátaí pá teagascóra níos airde de bharr méaduithe ar chomhaontuithe pá náisiúnta.

#### Cúrsaí

D'fhan líon iomlán na gcúrsaí curtha ar siúl ag soláthraithe maoinithe faoin gclár seo comhsheasmhach i 2007 ag 97 ina iomlán. Is méadú de 9 (24%) é seo i sa líon cistithe ag BTEI cothromaithe i gcoinne titime de 8 (16%) i líon na gcúrsaí maoinithe ag CCP.

The level of participation in 2007 by individuals from the immigrant communities is outlined in the diagram below. The figures in the table above indicate a combined immigrant participation rate of 8%, up from 6% in 2006. Reliable statistics are scarce in relation to the immigrant population both nationally and locally, as the economic migrant population is mobile in pursuit of work and consequently slow to put down community roots. Nationally a figure of 10% is quoted.



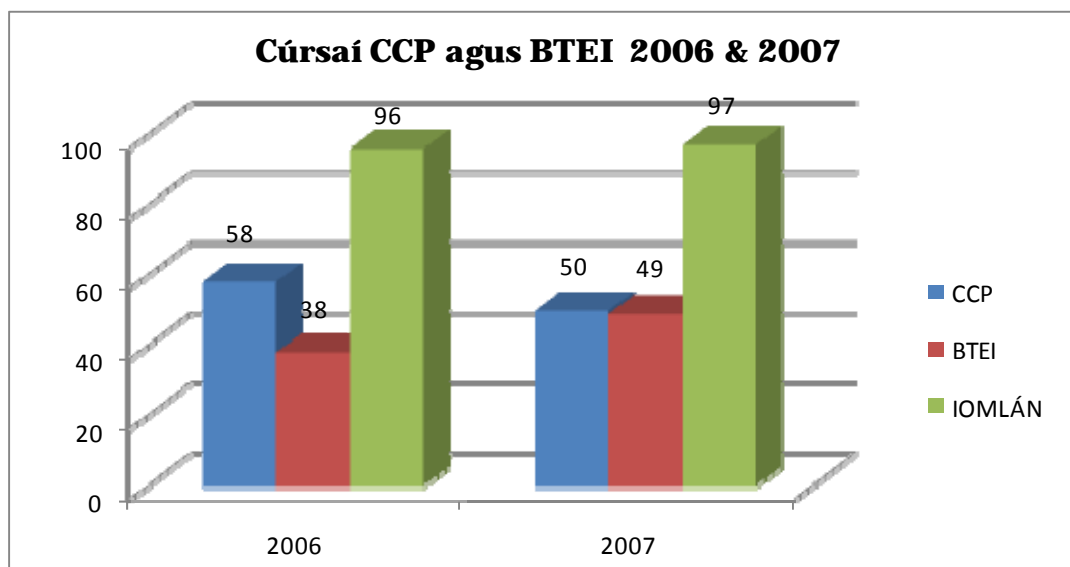
### Back to Education Initiative (BTEI) and Cork City Partnership (CCP) funding

Both of these funds are combined to resource an area-based approach to providing certified courses through the locally based Community Education Networks, offering opportunities for progression mainly from uncertified community education.

The budget increased overall by €27,620 approx in 2007. This increase was largely due to expanded provision funded by BTEI. This enabled an increase in the tutor hours allocated for certified courses by almost 400, while still meeting the higher tutor pay rates due to national pay agreement increases.

### Courses

The number of courses run by providers funded under this programme remained steady in 2007 at 97 in all. This corresponds with an increase of 9 (24%) in the number funded by BTEI balanced against a drop of 8 (16%) in the number of courses funded by CCP.



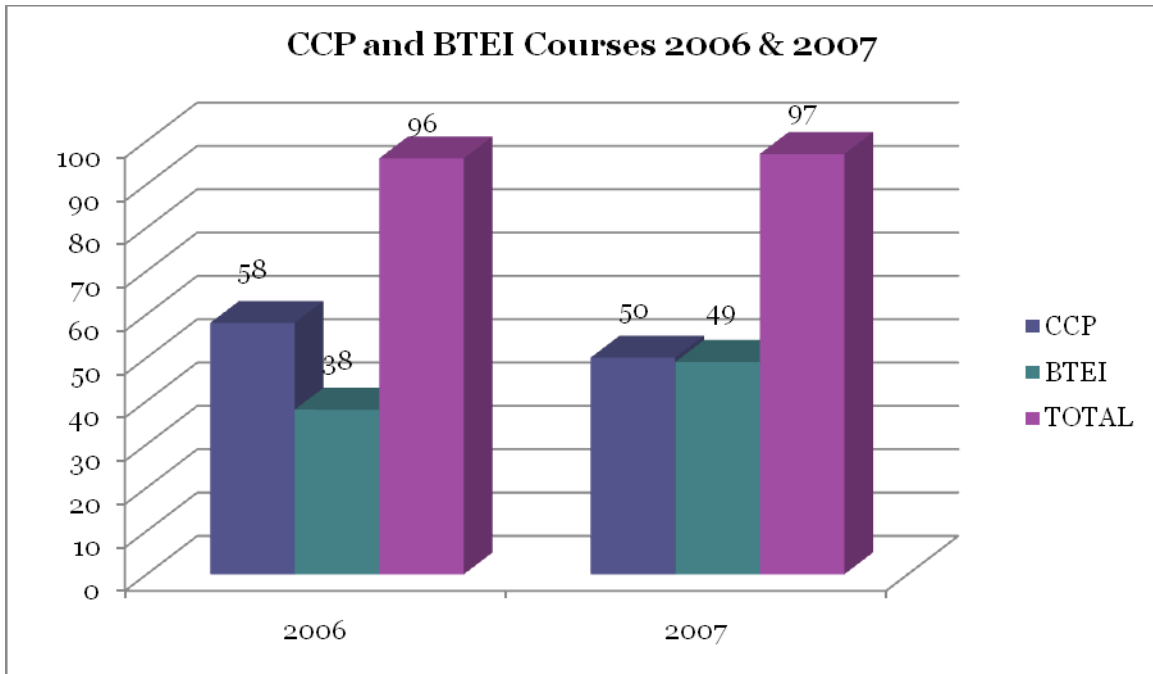

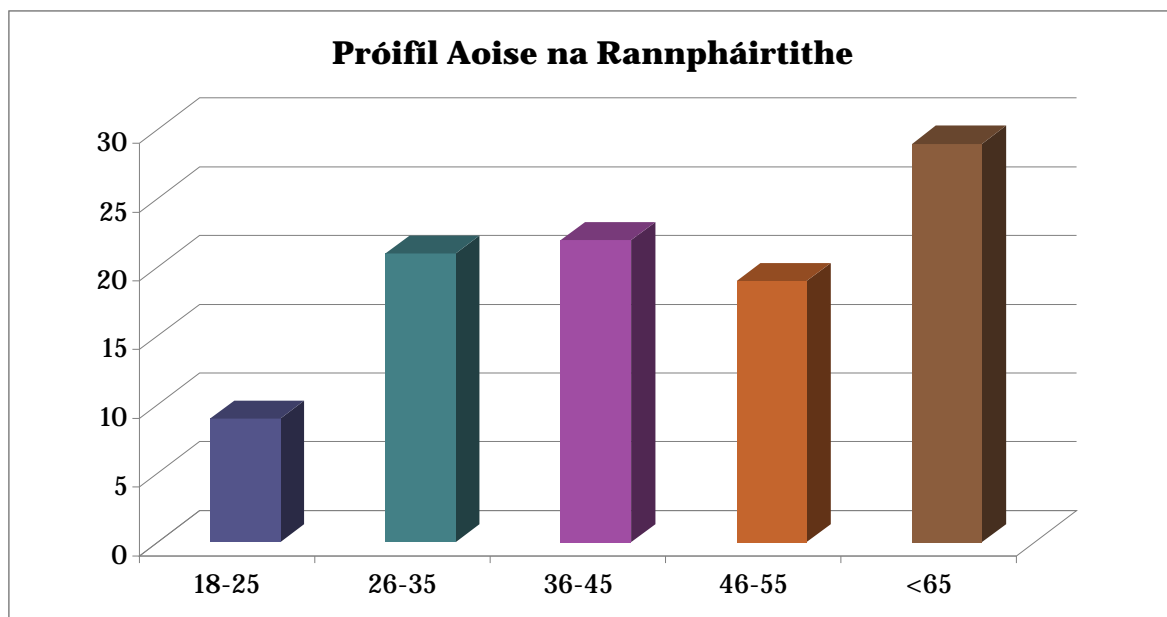

The number of learners participating in courses funded by BTEI/CCP declined by 3% in 2007, a similar decline to the previous year. The number of learners funded by BTEI was down at 373, a decline of 5.5%, whereas the number of learners supported by CCP funding declined less markedly compared with 2006.

### Profile of learners – Age

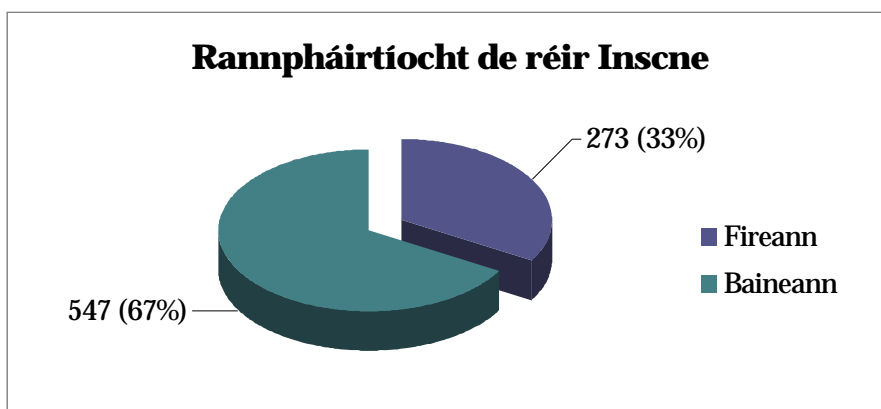
The age profile of learners in Certified Community Education courses is reasonably evenly spread across the age bands, with approximately one third under the age of 35, one quarter between 35 and 45, and almost half aged 46 and over. 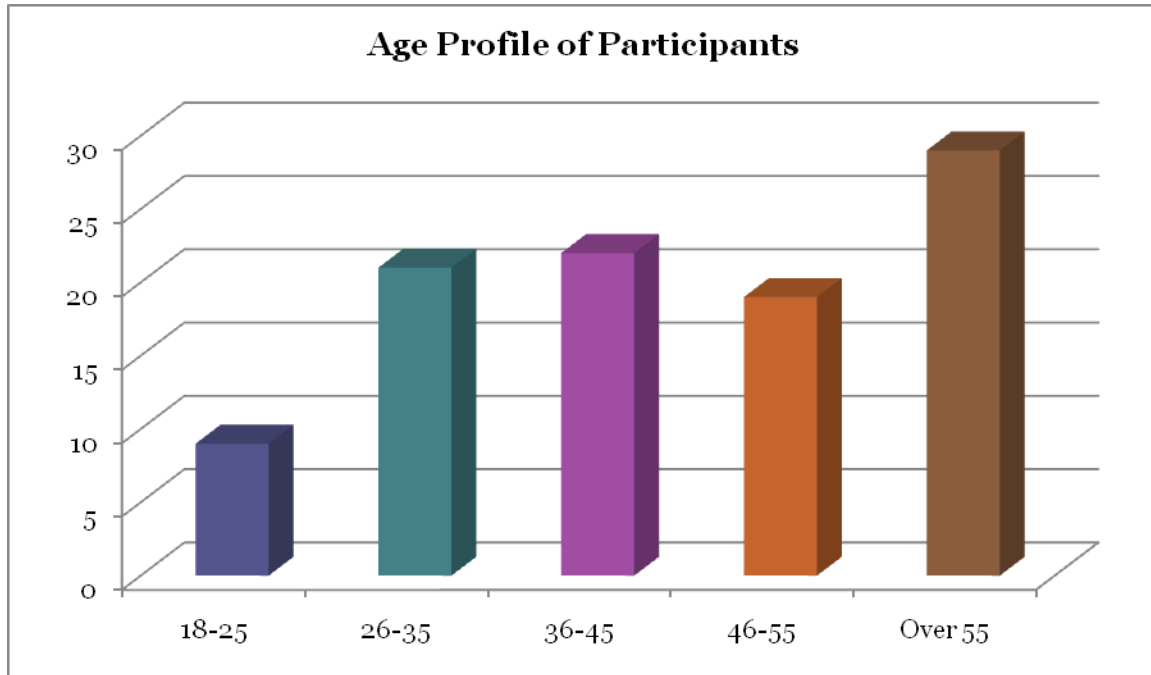

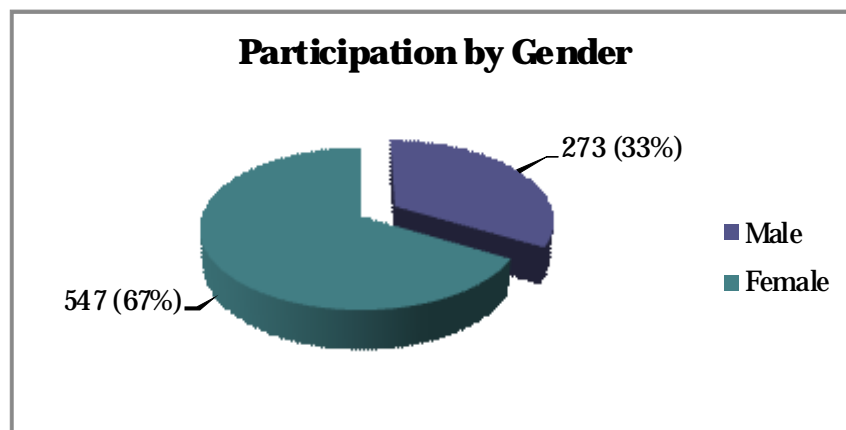

## Adult Basic Education Service (Literacy)

The ABE (Literacy) Schemes are the fundamental unit of the ABE Literacy Service and are an integral part of the local communities in which they operate. Eight ABE Literacy Schemes each provide the service in a district of the city. The districts cover the majority of the disadvantaged city areas, including the four RAPID areas. A ninth Literacy Scheme provides a citywide service for members of the Travelling Community.

### Learners

In 2007, 1,389 learners were registered with the Adult Basic Education Service. This is an increase of 14.4% over 2006.

Increasing use will be made of a variety of methodologies to enhance literacy development within the context of art, computers and IT skills, Health & Safety, and Driver Theory Tests, as well as innovative programmes within a family context through Family Based Learning. This programme is specifically designed to meet the needs of adult basic learners.

#### Intensive Tuition Adult Basic Education (ITABE)

An intensive programme aimed at providing adults with increased skills and competencies. The level of provision in this area increased dramatically in 2007 (2006 – 34 participants).

### FAS/VEC Return to Education (R2E)

This is aimed at participants on the FAS Community Employment Schemes in the City. It lasts for 30 weeks. It is an intensive basic skills programme that includes Numeracy, Information Technology, Modern Languages, Personal Development, English, Communications and Learning through the Arts.

Tá Treoirsheirbhís Aosaigh Chathair Chorcaí maoinithe faoin Roinn Oideachais agus Eolaíochta (DES) faoin bPlean Forbartha Náisiúnta agus tá sé comhtháite isteach i soláthar oideachais aosaigh faoi CG Chathair Chorcaí. Bunaíodh é i mBealtaine 2006 faoi Phas IV den Tionscnamh Treorach Oideachais Aosaigh (AEGI), a bhí bunaithe i 2000 ag DES agus a bhfuair comhairliúchán ón Ionad Náisiúnta do Threoir in Oideachas (NCGE). Soláthraíonn an AEGI treoir réamh-dhul isteach, leanúnach, agus réamh-dhul amach do ghrúpaí sprice ar leith:

- Eolas ar chúrsaí, gairmeacha, cistiúchán, etc don phobal i gcoiteann
- VTOS
- BTEI

I 2007 ceapadh treoirchomhairleoir sa bhreis don tseirbhís, mar sin ag tabhairt an cumas don seirbhís soláthair sa bhreis a chur ar fáil. Lean Treoirsheirbhís Aosaigh Chathair Chorcaí ar aghaidh á bunú féin i 2007, agus léiríonn líon na gcliant a úsáideann an tseirbhís an fhorbairt seo. Do na céad sé mhí de 2007, d'oibrigh CCAGS ó cheanncheathrú nua CG Chathair Chorcaí i gCé Lavitt agus i mí Iúil 2007, bhog an fhoireann treorach isteach sna háitribh athchóirithe ar an Meal Theas. Tugann an suíomh áisiúil seo an cumas do chliant teacht isteach go héasca d'eolas nó chun freastail ar choinne ina n-aonair le Treoirchomhairleoir. Oibríonn seirbhís lár na cathrach amanna 'siúl-isteach', Luan go Déardaoin 10.00rn go 12in agus 2.30in go 4.30in.

Cé go raibh oibriú as suíomh lár na cathrach i gceist leo, leantar ar aghaidh i mbliana le fáis suntasach na teagmhála, an atreoraithe agus soláthair bhunaithe sa phobal. Is eilimint leanúnach fós é tógail líonraí agus choibhnis san obair treorach mar chomhlánann agus feabhsaíonn an tseirbhís soláthair oideachais bhunaithe i suíomhanna áitiúla, pobail.

## Cork City Adult Guidance Service

---

The Cork City Adult Guidance Service is funded by the Department of Education and Science (DES) under the National Development Plan and is integrated into adult education provision within the City of Cork VEC. It was established in May 2006 under Phase IV of the Adult Education Guidance Initiative (AEGI) which was established in 2000 by DES and advised by National Centre for Guidance in Education (NCGE). The AEGI provide pre-entry, on-going and pre-exit guidance to specific target groups:

- Information on courses, careers, funding etc. to the general public
- VTOS
- BTEI
- Literacy
- Community Education
- Education Finance Board

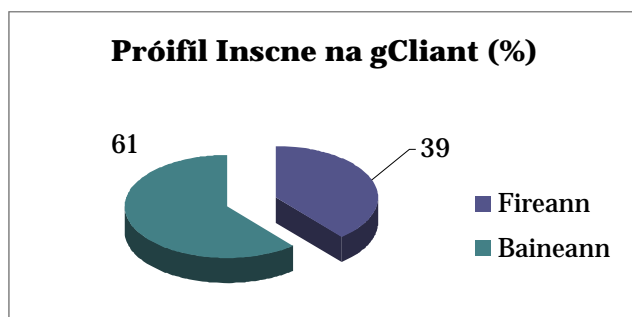
In 2007 an additional guidance counsellor was appointed to the service, thus enabling the service to further expand provision. Cork City Adult Guidance Service continued to establish itself in 2007 and the numbers of clients using the service reflects this development. For the first six months of 2007, CCAGS operated from the City of Cork VEC' new administrative headquarters in Lavitts Quay and in July 2007 the guidance team moved into refurbished premises on the South Mall. This convenient location enables clients to drop in for information or attend a one-to-one appointment with a Guidance Counsellor. The city centre service operates walk-in times from Monday to Thursday 10.00am to 12pm and 2.30pm to 4.30pm.

Although operating out of a city centre location the community based contact, referral and provision continued to develop significantly this year. Networking and relationship building has continued to be an on-going element of the guidance work as the service complements and enhances established education provision in local, community settings.

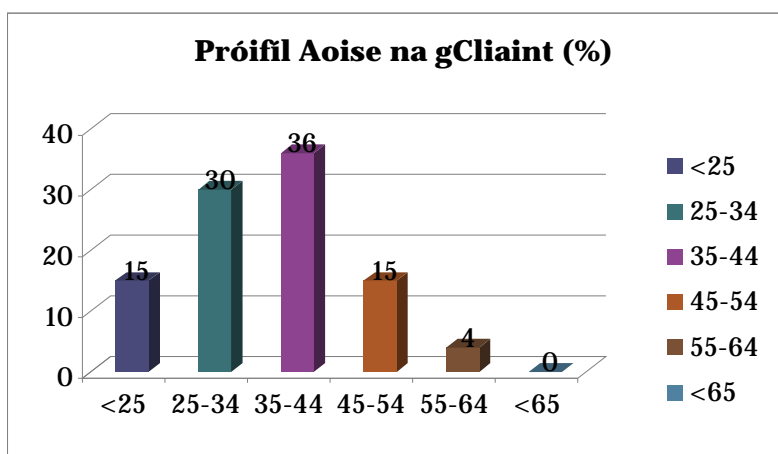
### Service Provision

- **General Public Enquiries** – **254** individuals contacted the service seeking information, they did so via phone, email and drop-in.
- **Group guidance** – **55** new groups were met for group guidance.

- **Treoir duine-le-duine** – buaileadh le **320** daoine aonair ar bhonn duine-le-duine do threoir
- **Oideachas Pobail** – bhí **157** duine aonair den 320 feicthe do threoir duine-le-duine bunaithe i bpobail áitiúla.
- **Atreoruithe** – tháinig 23% de na hatreoruithe do threoir ó chuartheanna ranga seirbhíse treorach, 10% ó GC Chathair Chorcaí agus bhuail 8% isteach don seirbhís.
- **Gnóthú oideachais** – bhí an Ardteistiméireacht ag 11% dóibh siúd a bhain úsáid as an seirbhís, bhí oideachas bunscoile ag 9% agus bhí níos lú ná an Ardteistiméireacht ag 8%.



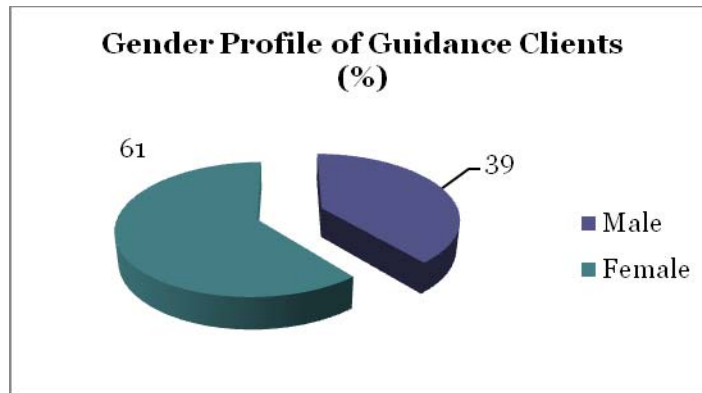

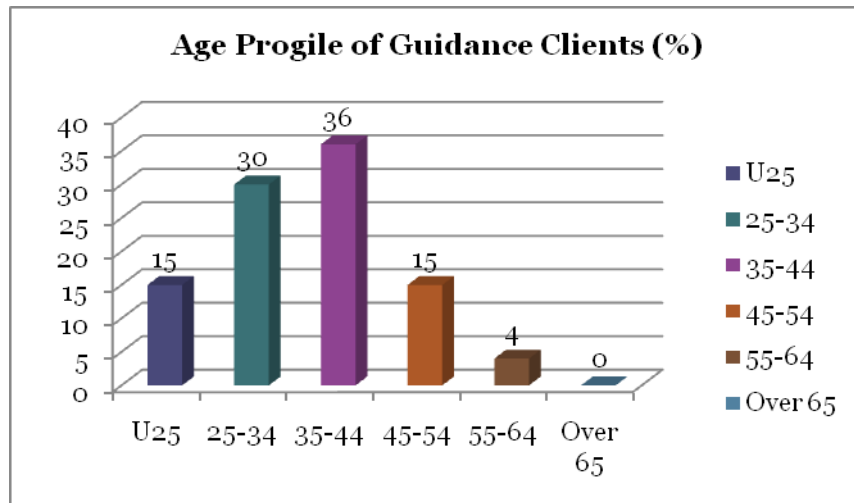
Faoi mar is féidir a fheiceáil ón ngraf, tá 36% idir na haoiseanna de 35 agus 44 bliain d'aois. Tá sé seo i líne leis an treocht náisiúnta.

**One-to-one guidance** – 320 individuals were met on a one-to-one basis for guidance.

- **Community Education** – 157 individuals of the 320 seen for one-to-one guidance were based in local communities.
- **Referrals** – 23% of referrals for guidance came from guidance service class visits, 10% of referrals came from City of Cork VEC and 8% dropped into the service.
- **Education attainment** – 11% of those who used the service had the Leaving Certificate, 9% had primary education and 8% had less than the Leaving Certificate.



A significant number of guidance clients are referred by local communities and women in general tend to be more active in their local environments which may explain the gender breakdown.



As can be seen from the graph 36% are between the ages of 35 and 44 years of age. This is in line with the national trend.
